## AKTA PERKHIDMATAN KEWANGAN DAN SEKURITI LABUAN 2010

PERATURAN-PERATURAN PERKHIDMATAN KEWANGAN DAN  
SEKURITI LABUAN (PINDAAN) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 196 Akta Perkhidmatan Kewangan dan Sekuriti Labuan 2010 [*Akta 704*], Menteri, atas syor Lembaga, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkhidmatan Kewangan dan Sekuriti Labuan (Pindaan) 2023**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2024.

## LABUAN FINANCIAL SERVICES AND SECURITIES ACT 2010

## LABUAN FINANCIAL SERVICES AND SECURITIES (AMENDMENT) REGULATIONS 2023

IN exercise of the powers conferred by section 196 of the Labuan Financial Services and Securities Act 2010 [*Act 704*], the Minister, on the recommendation of the Authority, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Labuan Financial Services and Securities (Amendment) Regulations 2023**.

(2) These Regulations come into operation on 1 January 2024.

**Amendment of Third Schedule**

2. The Labuan Financial Services and Securities Regulations 2010 [*P.U (A) 416/2010*] are amended in the Third Schedule by inserting after subitem 5(*k*)(*v*) and the particulars relating to it the following subitem and particulars:

	“(vi) external rent-a-captive;	1,000”.
