PADA menjalankan kuasa yang diberikan oleh seksyen 156 Akta Perkhidmatan Kewangan dan Sekuriti Islam Labuan 2010 [Akta 705], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkhidmatan Kewangan dan Sekuriti Islam Labuan (Pindaan) 2023.**

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2024.

LABUAN ISLAMIC FINANCIAL SERVICES AND SECURITIES ACT 2010

LABUAN ISLAMIC FINANCIAL SERVICES AND  
SECURITIES (AMENDMENT) REGULATIONS 2023

IN exercise of the powers conferred by section 156 of the Labuan Islamic Financial Services and Securities Act 2010 [Act 705], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Labuan Islamic Financial Services and Securities (Amendment) Regulations 2023**.

(2) These Regulations come into operation on 1 January 2024.

**Amendment of Third Schedule**

2. The Labuan Islamic Financial Services and Securities Regulations 2010 [P.U (A) 417/2010] are amended in the Third Schedule by inserting after subitem 5(f)(v) and the particulars relating to it the following subitem and particulars:
